# RAYMARINE 2008 HD SALES EVENT REBATE TERMS AND CONDITIONS

## 1. GETTING YOUR REBATE

In order to be eligible to receive your 2008 Raymarine HD Sales Event Mail-In Rebate:

- (a) Purchase a complete Qualifying System between October 2 through November 20, 2008 (the "Effective Period"). Qualifying Systems and corresponding rebates are listed on the front of this form and on HD Sales Event in-store promotional materials. All components of the Qualifying System must be new and must be purchased on the same date and from the same authorized Raymarine retailer or dealer in order to qualify for this rebate.
- (b) Complete the front of this form and sign it in the space provided. Your signature indicates your agreement to comply with and be bound by these terms and conditions.
- (c) Cut the UPC label(s) from the packaging of each product purchased. See the front of the rebate form for an example UPC label
- (d) Mail the completed form together with the UPC label(s) a copy of your fully dated sales receipt showing your purchase of the applicable Qualifying System FOR EACH COMPONENT of the Qualifying System to the address listed in Paragraph 3 below. Please check the box on the front of this form if you have registered your warranty information online at [www.raymarine.com](http://www.raymarine.com). This completed form and your sales receipt will constitute your "Claim". YOUR CLAIM MUST BE POSTMARKED ON OR BEFORE DECEMBER 20, 2008 IN ORDER FOR YOU TO BE ELIGIBLE TO RECEIVE A REBATE.

## 2. HD TRADE-IN DAYS ADDITIONAL REBATE:

Raymarine's HD Trade-in Days promotion will run between October 2nd through 5th, 2008 (the "Trade-in Period"). If you purchase a complete Qualifying System during the Trade-in Period and, at the time of such purchase, you also provide your authorized Raymarine dealer with any brand of marine electronics screen (may include any radar, chartplotter, fishfinder or multifunction display), you will be eligible to receive an additional \$200 in addition to your HD rebate (an "Additional Rebate"). ADDITIONAL REBATES ARE NOT AVAILABLE OR OFFERED WITHOUT A CORRESPONDING PURCHASE OF A QUALIFYING SYSTEM AT THE SAME TIME AS THE TRADE IN. IN ORDER TO QUALIFY FOR AN ADDITIONAL REBATE, YOU MUST COMPLETE IN FULL THE OFFICIAL RAYMARINE TRADE-IN DAYS REBATE FORM AND INCLUDE IT WITH YOUR CLAIM. Incomplete Claims (including claims without UPC labels) or Claims that are postmarked after December 20, 2008 will not be processed and not be eligible for this rebate. Raymarine is not responsible for incomplete Claims or Claims lost in the mail. You acknowledge that your participation in this rebate program imposes no liability on Raymarine. In particular, Raymarine is not liable for any consequential damages. If you return any part of your Qualifying System you will not be eligible to receive the applicable rebate. Please allow up to 8 weeks for the processing of Claims. All rebates issued in United States Dollars.
